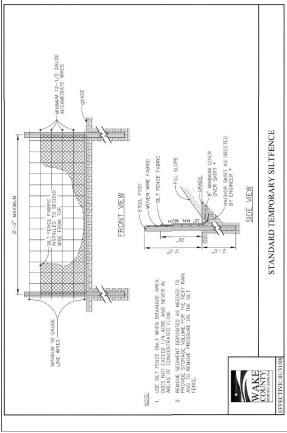
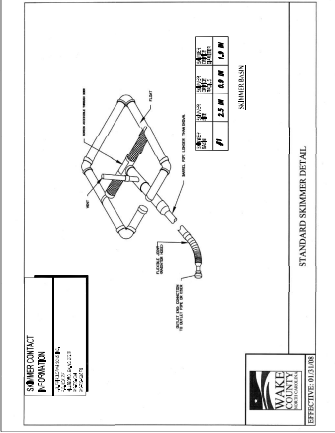
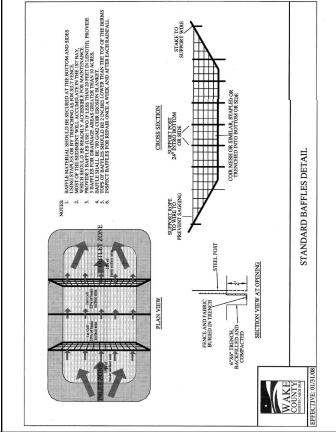
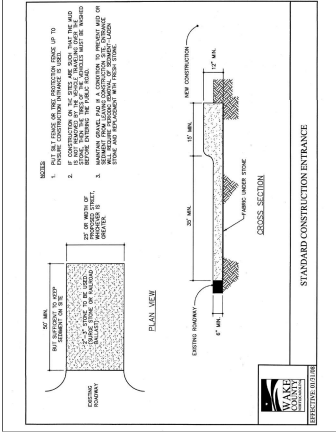
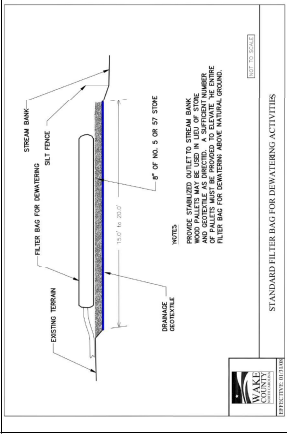
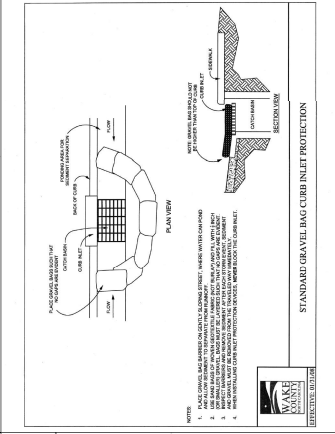
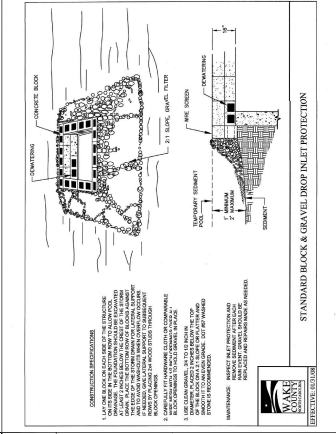
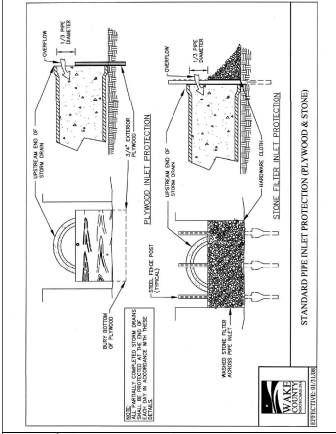
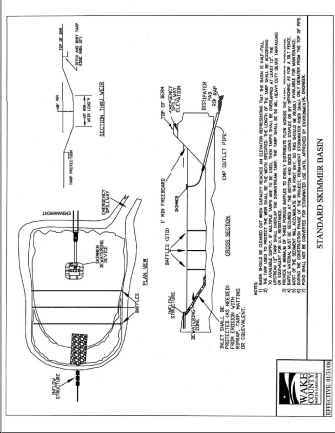
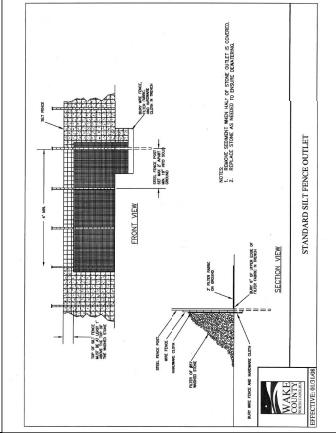
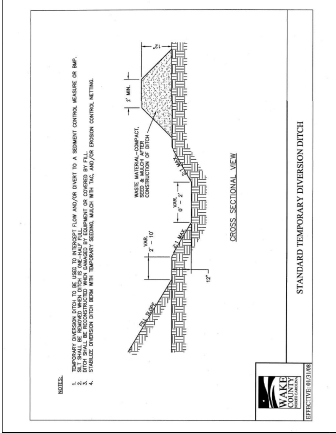
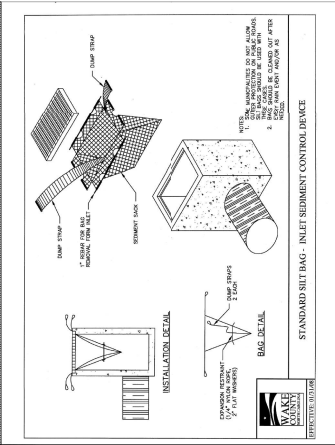
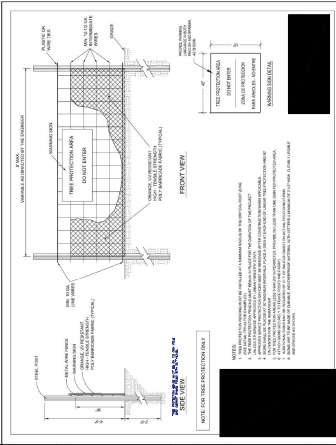
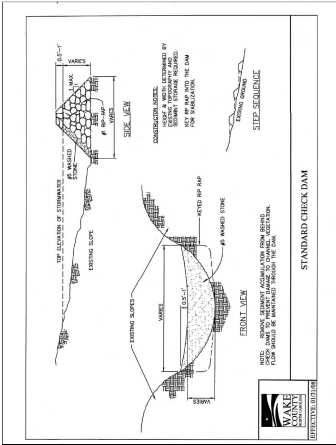
WATER MAIN PROFILE VIEW

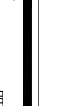
