


Monthly Report for May 2024

The Planning Department has issued 508 Certificate of Occupancies as of the end of May 2024 for FY24 for Residential Building Permits. For the month of May, the Town of Zebulon issued out 36 Residential Building Permit COs, 7 Commercial COs, 6 Residential Accessory Building Permits COCs & 13 Trade Permit COCs.



Code Enforcement:





As the Planning Department has seen an increase in residential development, code enforcement has been busy. In the month of May, Code Enforcement completed 70 initial setback inspections and 43 final inspections. Since we are moving into the spring/summer months we have noticed an increase in code enforcement cases for tall grasses. Our Code Enforcement officers responded to 203 code violations for the month of May.
